



## Introduction to WIOTC's New Affiliated Commissions

World Internet of Things Convention (English abbreviation “WIOTC”) is an IoT international organization that is innovative, authoritative and nonprofit and a nongovernmental organization recognized by the United Nations Economic and Social Council (hereinafter referred to as “the organization”). All commissions related to various industries are the directly affiliated agencies of the organization.

The purpose of the organization is to build an intelligent world where all things are interconnected.

The aim and goal of the organization is to mobilize all countries to formulate the world convention on internet of things and universally accepted standards, create the model and system of IoT economy as reference for the world, contribute to the UN Sustainable Development Goals and support the endeavor of building a community of shared future for mankind which is fully connected.

Having organized and convened six annual conferences and over 100 international forums and summits, the organization has published the *Beijing Declaration on the World IoT* and *World Internet of Things White Paper*, established the World IoT Ranking List (WIOTRL Top 500), created the World IoT Awards (WIOTA) and launched the IoT World Fair. Besides, the organization has fathered the theoretical basis of “IoT representing wisdom revolution” and created the new cognition and definition, the top-level architecture system, the new global connection system, the new economic pattern and sustainable development route of visualized real-time tracking and tracing plus commercial customization that are related to IoT. It has won the recognition and involvement of international organizations including UNESCO, UNDP, UNCTAD, ITU, ISO, IEEE and IEC as well as government agencies and organizations from nearly one hundred countries in the world. Of particular note, the organization has forged good relations with government agencies, ambassadors and diplomats as well as famous



enterprises.

In order to promote the innovative development of economy and society in the world, reduce the digital divide, strengthen exchanges and cooperation of global companies engaged in Internet of Things and digital technology, help enterprises establish the industrial chain along upstream and downstream ecological market of supply chain, create the industrial market of global digital economy and ecosystem, the organization will establish specialized commissions on industry, agriculture, energy, transportation and auto intelligence, logistics, culture, education, tourism, smart city, artificial intelligence, aerospace, ecological and environmental protection as well as finance and insurance by selecting leading enterprises in all fields, companies related to the upstream and downstream industrial chain, international organizations, institutes and think tanks. All these commissions are the directly affiliated agencies of WIOTC, follow the purpose, principle and advantage of the organization and represent the agencies of global IoT industry of digital economy.

We welcome transnational and leading companies, enterprises that are already listed in the World IoT Ranking List Top 500 as well as government agencies to co-found commissions in relevant fields (digital economy) by applying for the membership of the commissions so that we can contribute to the innovative development of world economy and society and the building of an intelligent world where all things are interconnected.

## **Main Rights and Interests of Initiating Members**

1. Enjoy the qualification and honor of member in the directly affiliated commission under the World Internet of Things Convention (WIOTC), a nongovernmental organization recognized by the UNECOSO, the chance to gain the influence and authority of the international organization, and the support given by the organization for pooling the resources to win the support of local government and project implementation;
2. Enjoy the right to propose and vote for the technology, standard, economy, trade and the expansion of industrial chain and ecological market; support the



building of ecosystem of enterprises and the expansion of domestic and international market of sales;

3. Enjoy the right to propose, assess and vote for the standards of international groups and relevant rights for the formulation, assessment, verification and implementation of these standards; involvement in the formulation of related international rules of IoT new economy of this industry;

4. Enjoy the right of election as member of the presidium of the directly affiliated commission of the organization and have the qualification of acting as rotating position of president, vice president, secretary-general and deputy secretary-general of the commission.

### **Function of Commission**

1. Provide suggestions or opinions for government agencies from other countries to make the strategic plans of digital economy in various fields related to IoT and play the function and role as an IoT international organization.

2. Admit members from upstream, midstream and downstream enterprises in various industries, support the expansion of ecological market system of industrial and digital economy pertaining to IoT and help to expand the market of the industry.

3. Focus on the work of formulation, test, verification and implementation of global group standards of the industry related to IoT new economy, guide member units to draft corporate standards, carry out the promotional activities of international standards, do research while offering suggestions on the guideline, policy, supporting technical measures of standardization.

4. Initiate statistical and investigative activities to analyze the trend of development, give advice on the development of industry and enterprises, organize counselling and evaluation of the industry, IPR protection, investment and financing and other services.

5. Facilitate the cooperation of technology and economic trade among all member units engaged in technological development, scientific management,



academic research and exchanges and press ahead with the reform and innovative development of this industry.

6. Organize research and inspection in relevant industries, study the development law of this industry, publish the report of relevant industries, and popularize new idea and development strategy of IoT and digital economy.

7. Organize various talent training activities, develop the cause of public interests of the sector, enhance the social responsibility of enterprises in this industry.

8. Give support to WIOTC events every year, co-sponsor related forums, implement the strategy of brand and promote high-tech and brand products within the relevant industries.

9. Organize international exchanges and cooperation, play the role of government agencies and business associations as bridge and bond, and try to obtain the support of national policies and preferential measures conducive to the industry.
